Loukas Mistelis is the Clive M Schmitthoff Professor of Transnational Commercial Law and Arbitration and the Director of the QMUL-UNIDROIT Institute of Transnational Commercial Law at Centre for Commercial Law Studies, Queen Mary University of London. He joined Queen Mary University of London in 1998 and became a professor in 2005. He has also been Director of the QMUL School of International Arbitration (2002-2019). Professor Mistelis was educated in Greece, France, Germany and Japan. He has been a member of the Athens Bar since 1993 and is Registered European Lawyer with the Solicitors Regulation Authority in the UK. He is member of Chartered Institute of Arbitrators (CIArb) since 2001 and became Fellow of the CIArb (FCIArb) in December 2016. He is visiting professor at numerous university around the globe. His substantial arbitration experience covers ad hoc and ICC, ICSID, LCIA, UNCITRAL, SCC, Swiss Chambers and Moscow cases. He is also Chair of the Executive Board of EFILA.
